I hereby release, covenant not to sue, discharge, and hold harmless CSE, its employees, agents, sponsors, partners, vendors, venue's, local and state jurisdictions, their representatives and representatives, of and from Claims, including all liabilities, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of CSE, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after participation in any CSE event and or associated activity.

## US Lacrosse, Inc. Waiver

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS USL, and their officers, officials, agents, and/or employees, other participants, volunteers, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
